




# **Complete Application**

This notice advises that, on October 23, 2025 the City of Markham received complete Official Plan and Zoning By-law Amendment applications (the "Applications") for the property at the northeast corner of Highway 404 and Elgin Mills Road East (the "Subject Lands"). The submission was made by Arcadis Professional Services (Canada) Inc. on behalf of the landowner (the City of Markham) and meets the requirements to begin the City's review. **This notice is NOT an approval by the City of Markham.** 

## The Property

The 3.1-hectare (7.6 acre) Subject Lands are located at the north-east corner of Highway 404 and Elgin Mills Road East and is described legally as Part of Lot 26, Concession 3. It is currently used for agricultural purposes.



# The Applicant's Proposal

The purpose of the Applications is to redesignate the Subject Lands from employment to mixed use. The concept plan includes four buildings ranging from 10-15 storeys in height (Buildings A, B, C and D), for the purposes of retirement and seniors living and three 4 storey buildings (Buildings E, F and G) for the purpose of medical office, retail, childcare and private school uses.

**Personal Information:** Personal information collected in response to this planning notice will be used to assist City staff and Council to process this application and will be made public.

## What if I want to appeal the proposal?

- i) If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Markham, or the approval authority, to the Ontario Land Tribunal, but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Markham before the proposed official plan amendment (or official plan) is adopted or the by-law is passed, the person or public body is not entitled to appeal the decision.
- ii) If a person or public body does not make oral submissions at a public meeting, or make written submissions to the City of Markham before the proposed official plan amendment (or official plan) is adopted or the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

That means if this this official plan amendment (or official plan) or by-law is appealed to the Ontario Land Tribunal and you would like to participate in the appeal in some form, you **must** make an oral submission at a public meeting, or submit written comments to the City Clerk, before the official plan amendment (or official plan) is adopted or the by-law is passed by Markham City Council.
