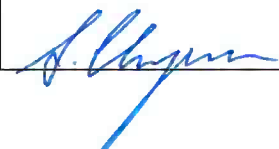

Report on the Audit of the Financial Statement

Qualified Opinion

We have audited the accompanying Financial Statement on prescribed Form 4 of the Darren Soo Campaign (the "Campaign") for Ward 6 Councilor, City of Markham, which comprises a statement of campaign income and expenses and accompanying Schedules 1 and a calculation of surplus or deficit ("financial statement").

In our opinion, except for the possible effects of the matter described in the "Basis for Qualified Opinion" paragraph, the financial statement of the Campaign for the period from August 10, 2022 to January 3, 2023 is prepared, in all material respects, in accordance with the financial reporting provisions of section 88.25 of the Ontario Municipal Elections Act, 1996 ("Act") and in the prescribed form issued by the Ministry of Municipal Affairs and Housing of Ontario ("Ministry").

Basis for Qualified Opinion

Due to the inherent nature of the transactions of the Campaign, the completeness of contributions received and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these amounts was limited to the amounts recorded in the Campaign's accounting records and we were not able to determine whether any adjustments might be necessary to contributions received, expenses and surplus.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statement* section of our report. We are independent of the Campaign in accordance with the ethical requirements that are relevant to our audit of the financial statement in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Emphasis of Matter - Basis of Accounting and Restriction on Use

The financial statement is prepared to assist you to meet the requirements of the Act and the accounting guidelines issued by the Ministry. As a result, the financial statement may not be suitable for another purpose. Our report is intended solely for you and the municipal clerk. Our opinion is not modified in respect of this matter.

INDEPENDENT AUDITOR'S REPORT (cont'd)

The Candidate's Responsibility for the Financial Statement

The candidate is responsible for the preparation of the financial statement in accordance with the reporting provisions of section 88.25 of the Act and in the prescribed form issued by the Ministry and for such internal control as the candidate determines is necessary to enable the preparation of a financial statement that is free from material misstatement, whether due to fraud or error.

Those charged with governance are responsible for overseeing the Campaign's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statement

Our objectives are to obtain reasonable assurance about whether the financial statement is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial statement. As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statement, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Campaign's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the candidate.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
