

# **Fall 2019 Swimming Lesson & Swimming Program Registration Contest**

## **RULES**

**ELIGIBILITY** – The Contest is open to all Fall 2019 swimming lesson and swimming program registrants (residents of Markham and non-residents) who have reached the age of majority in Ontario at the time of the Contest (or who provide proof of parental/legal guardian consent). The Contest is not open to elected officials or employees of The Corporation of the City of Markham (“Markham”), or members of their immediate families living in the same household. Markham reserves the right to verify the eligibility of the potential winners.

**CONTEST PERIOD** - The Contest starts on Thursday, August 15, 2019, and ends on September 27, 2019.

**ENTRY** – Register for a Fall 2019 swimming lesson or swimming program and automatically be entered in the draw. Receive one entry for every swimming lesson or swimming program you register for. Markham shall not be responsible for lost, late, misdirected or stolen entries, or the inability to process entries. All Contest entries are the property of Markham.

**PRIZES** - There will be **15** prizes awarded as follows:

- **10 Swimming Lessons**

*Each pass entitles one individual to a free season of Markham-run group swimming lessons during the Winter 2019-2020 session (semi-private, private and aquatic leadership lessons and programs are not included).*

- **5 Family Drop-in Passes**

*Each pass entitles you and your family (maximum 6 members total with a maximum of 2 adults residing at the same address) to drop in for free at Markham-run activities such as swimming, skating and a variety of sports at your local community centre from September to December 2019. One time use only.*

Only one prize will be awarded per Contest winner. The odds of winning will be determined by the number of eligible entries received by the Contest closing date. Prizes must be accepted as awarded, and are non-transferable and non-refundable. Markham reserves the right to substitute any prize with a prize of equal or greater value. All prizes are awarded as-is, and no warranties, guarantees or representations are implied or expressed.

**DRAW** – Potential winners will be selected by random draw from among all eligible entries received by the Contest closing date. The draw will be held in Markham, Ontario on Monday, September 30, 2019. Potential winners will be contacted by email. Up to three attempts to contact a potential winner will be made. After three unsuccessful attempts have been made to contact the potential winner, another name will be drawn. This process will be repeated until all prizes have been awarded.

**PRIZE CLAIM** - Prior to receiving the prize, each potential winner will be required to: (1) show valid photo ID; (2) correctly answer a skill-testing question; and (3) sign a declaration confirming compliance with the Contest Rules, releasing Markham and its representatives from all liability in connection with the Contest and the prize, and consenting to the use of his/her name, city of residence and photograph (or other likeness), without compensation, in any publicity carried out by Markham. The signed declaration must be received by Markham prior to the release of the prize.

**LIMITATION OF LIABILITY** - By entering the Contest, entrants agree that Markham shall not be liable for, and entrants agree to release, indemnify and hold Markham, its elected officials, directors, officers,

employees, agents and affiliates harmless from any injuries, losses, damages, claims, actions and any liability of any kind resulting in whole or in part, directly or indirectly from entrant's participation in the Contest or acceptance, possession or use of any prize that may be won.

**PERSONAL INFORMATION** - By entering the Contest, entrants consent to their personal information being stored, used and processed by Markham for the purposes of this Contest and any other purpose indicated by the entrant.
