### Purpose

- To award the contract for the West Thornhill Phase 1A Storm Sewer and Watermain Replacement;
- To award the contract administration and inspection services; and
- To increase the stormwater fee rates to address the revised cost estimate for the overall Flood Control Program from \$186M to \$234M as outlined in report.



# Background

- The City-wide Flood Control Program is a 30 year program with an estimated cost of \$186M based on 2009 and 2010 Class EA cost estimates.
- To support the program, on November 26, 2013 Council approved stormwater fee rates (starting in 2015) of:
  \$36 per unit/year for residential and multi-residential properties
  \$21/\$100,000 CVA/year for non-residential properties.
- The West Thornhill area (Phase 1 & 2) is proposed to be completed in the first 5 year period by 2018 (see map).

### **West Thornhill Implementation Phases**



### **Phase 1A Improvements**

- New storm outfall to Don River on Doncrest Drive, east of Bayview Avenue;
- New storm sewers along Doncrest Drive and Daffodil Avenue, and along portions of Poinsetta Drive and Wildrose Crescent (proposed sewers are large diameter and up to 7 metres deep);
- New watermain on streets noted above and on Rosea Court, Spirea Court, and Sunflower Court;

 Storm water quality treatment device on Doncrest Drive;
 Reconstruction of roads along Doncrest Drive, Poinsetta Drive, and Daffodil Avenue;
 Roadway resurfacing of Rossea Court, Spirea Court and Sunflower Court.





Phase 1A Construction Tender

- Phase 1 (Bayview Glen Area) was divided into 3 areas (1A, 1B, 1C). Phase 1A has proceeded to tender.
- The Phase 1A construction tender package was sent to six prequalified contractors on April 24, 2014.
- Five contractors picked up the bid document and one submitted a bid. The bid price is \$11,051,079.47.
- Staff negotiated a cost reduction of \$571,810.38 (approx. 5.2% reduction)
- The revised price is \$10,479,269.09.
- The available budget for construction is \$5,673,965.58.
- The budget shortfall is \$6,153,329.16. June 16, 2014

# **Reasons for Budget Shortfall**

- Detailed design refinements to EA recommendations based on value engineering
- Challenging soil and ground water conditions identified through field investigations
- Most complicated, difficult phase to implement due to large drainage area, and large sewers in deep excavations that require extensive dewatering

## **Revised Flood Control Program**

- The cost estimate of the 30 years Flood Control Program has been revised from \$186M to \$234M (2014 dollars).
- The revised cost estimate reflects:

□ Phase 1A budget shortfall

- Phase 1A tender-based unit prices applied to the remainder West Thornhill future phases
- New preliminary design quantities for West Thornhill Phases 1B, 1C and 2 works



**Options Evaluated To Address Funding Shortfall** 

- Option 1: Cancel the tender and re-tender in July 2014
  Not recommended, potentially no bids, will not recover shortfall from design refinements
- Option 2: Cancel the tender and re-tender in Nov/Dec 2014
  - Not recommended, no guaranteed of lower price, delays, will not recover shortfall from design refinements
- Option 3: Award the Contract and maintain the approved stormwater fee rates and extend the collection of fees from 30 to 41 years

□ Not recommended, to collect beyond 30 year period

### **Options Evaluated To Address Funding Shortfall**

 Option 4: Increase stormwater fee rates to align with revised Flood Control Program costs as follows:

Sector	Stormwater Fee Rates (November 26, 2013)	Stormwater Fee Rates (Option 4)
Residential and multi- residential	\$36 per unit/year	\$47 per unit/year
Non-residential	\$21/\$100,000 CVA/year	\$29/\$100,000 CVA/year

- Recommended: fiscally prudent, align fee rates with revised program costs
- Updates to rates within five years to reflect updated project costs estimates, market condition, Gas Tax allocation, inflation, growth, administration costs, and revenue collection

Residential and multi-residential	\$36 per unit/year	\$47 per unit/year
Non-residential	\$21/\$100,000 CVA/year	\$29/\$100,000 CVA/year

## **Managing Traffic During Construction**

- Road closure is required during construction.
  - Doncrest Drive will be closed at Bayview for up to 6 weeks (summer 2014).
  - Laureleaf Road will be designated as detour route.
- Roads will remain open to local traffic.
  - Residents will be able to access their driveways at all times although there may be delays during working hours.
  - Access for emergency vehicles will be maintained.

Provisions will be made for collection of June 16 stolid waste and recycling materials
